CONSTITUTION

PSA STEREO CLUB OF SOUTHERN CALIFORNIA

ARTICLE I. - Name

This organization shall be called PSA STEREO CLUB OF SOUTHERN CALIFORNIA.

ARTICLE II. - Aims

The aims of this club shall be: promotion of stereoscopic photography through the association of its members for study and entertainment.

ARTICLE III. - Membership

Any person who is a member of the Photographic Society of America, of good character, practicing stereoscopic photography, is eligible for membership according to provisions prescribed in the By-Laws.

ARTICLE IV. - Officers

The officers shall consist of a President, a Vice-President, a Secretary, and a Treasurer, whose duties and manner of election shall be as prescribed in the By-Laws.

ARTICLE V. - Meetings

Regular meetings of the club shall be held as prescribed in the By-Laws. All business meetings shall be conducted in accordance with Robert's "Rules of Order."

ARTICLE VI. - Amendments

Section 1. Any proposed change of this Constitution may be presented by either a majority vote of the officers or by five or more members.

Section 2. Such proposed change must be presented in writing at a business meeting of the club. It shall then be tabled until the following regular business meeting; notice of the proposed change shall be given in the notice of the next regular meeting, when it shall be voted upon. The proposed change shall require at least a two-thirds affirmative vote of the members present.

ARTICLE VII. - Adoption

This Constitution and accompanying By-Laws shall be considered adopted when they have been approved by two-thirds or more persons present at an open meeting called for that purpose and who have paid the yearly dues specified in the By-Laws.

BY-LAWS

PSA STEREO CLUB OF SOUTHERN CALIFORNIA

ARTICLE I. - Membership

Any person who is a member of the Photographic Society of America, of good character, practicing stereo photography, whose application has been endorsed by a member of the club, and submitted together with the annual dues, shall be declared a member of the club upon the affirmative vote of a majority of the members present at a business meeting. Any member whose dues are in arrears one year or more shall be automatically dropped.

ARTICLE II. - Dues

The annual dues shall be \$5.00, payable in advance.

ARTICLE III. - Election of Officers

Section 1. The November meeting shall be designated the club's Annual Business Meeting, at which officers shall be elected. During the Meeting previous to the Annual Meeting, the President shall appoint a Nominating Committee to present a slate of officer nominees at the Annual Meeting.

Section 2. Such nominations shall be received at the Annual Meeting, and additional nominations may be made from the floor.

Section 3. All nominees shall be asked if they are willing to serve if elected, as a condition for placement of their names on the ballot.

Section 4. At the Annual Meeting the President shall appoint Tellers, who shall distribute ballots.

Section 5. The candidates receiving the highest number of votes shall be declared elected, and shall take office immediately.

ARTICLE IV. - Duties of Officers

Section 1. The <u>President</u> shall preside at all regular and special meetings of the club, serve as chairman of the Executive Council, and administer the affairs of the club with the assistance of the Council. He shall appoint all committee chairmen, and shall approve all bills before their payment, and all official matter to be published. He shall endeavor to assume active leadership of the club at all times.

Section 2. The <u>Vice President</u> shall preside at all meetings in the absence of the President, and shall assume the duties of that office in the event of death or resignation.

Section 3. The <u>Secretary</u> shall keep a record of proceedings of all regular and special meetings. He shall send out calls for special meetings and carry on and keep a file on the correspondence of the club. He shall maintain a complete and current list of membership, and shall present applications for membership. He shall fulfill any other duties not above specified but which are usually incumbent upon that office.

Section 4. The <u>Treasurer</u> shall act as custodian for all club funds, depositing them in one or more banking institutions approved by the Executive Council. He shall send out bills for dues and acknowledge their receipt, and pay all bills authorized by the President, keeping a detailed account of all receipts and disbursements. He shall make a semi-annual written report to the club of the condition of the Treasury, and shall present the books, accounts, vouchers, and an annual statement to the Auditing Committee.

Section 5. The Executive Council shall consist of the four officers above, plus the Past President and Chairman of the Membership, Program and House Committees.

ARTICLE V. - Committees

Section 1. The President shall appoint Chairmen for each of the three permanent committees. Each chairman shall then appoint no less than two additional members. The President also shall appoint Chairmen for a Nominations Committee and an Auditing Committee, and such other special committees as may be required.

Section 2. The <u>Membership Committee</u> shall promote club membership and, with approval of the Executive Council, plan any membership campaigns that may be desirable.

Section 3. The <u>Program Committee</u> shall plan a program for each meeting, providing instruction and entertainment in line with the wishes of the membership as a whole.

Section 4. The <u>House Committee</u> shall find a suitable meeting place, when necessary, and assume complete responsibility for all club property.

ARTICLE VI. - Meetings

Section 1. Regular meetings shall be held on the fourth Wednesday of every other month, beginning with the month of January.

Section 2. The November meeting shall be designated as the club's Annual Business Meeting for election of officers, and as the start of the club's fiscal year.

Section 3. Special meetings may be called by the President at his discretion.

ARTICLE VII. - Amendments

These By-Laws may be changed by an affirmative vote of a majority of the members present at a regular or special meeting, provided that there shall be a quorum present.

MINUTES

First official meeting of Board of Directors of PSA STEREO CLUB OF SOUTHERN CALIFORNIA held at home of President, Dr. Harold R. Lutes, on Saturday, January 7, 1956.

Read over list of officers, as elected at November meeting. Notes on business portion of the November meeting are attached hereto.

President stated that Committees should be formed and Chairman appointed.

Discussion and Kenneth Oppenheimer appointed Program Chairman

Treasurer Max Bruensteiner reported 19 members and \$95.00 in treasure.

All present asked to submit any outstanding bills to treasurer for payment.

Guest book suggested, and Secretary authorized to purchase same.

Suggested that there be a host and hostess at each meeting, in order that members and guests become better acquainted.

Identification badges suggested. Motion made, seconded and carried that same should be obtained. Maury Lank to handle this. Badges to be turned over to Stew Wilson, who will see that names are placed thereon.

President asked Vice-President John Stick for further ideas on Committees. Besides the above listed, he suggested a Technical and Analysis Committee. Mr. Stick stated he was of the opinion that members would like to show slides, and it would be a good idea to have a committee they could bring the slides to for analysis, and the following month to show these same slides with the analysis given. Also, members could bring questions to committee on stereo problems they might have, and these questions and answers could be read at the meeting; also that a circular might be printed up with these questions and answers. Mr. Stick suggested the STEREOGRAM could be contacted and this offer of analysis service made to them. Mr. Oppenheimer stated in a communication he had received from Colonel Joe Perry, it was suggested the club might have not only competitions with analysis, but award points, certificates, badges, and have national memberships. Discussion on the possibility of Associate Memberships. Discussion regarding widening scope of "analysis program" to handle same from all parts of the country.

Board Members decided that this was quite an undertaking for the club in just starting out, and that rather than start it and for some reason have it fail, it would be better to keep this long range program in mind as a goal for the club, and which can be done at a later date, when more details can be worked out.

John Stick suggested a committee to work on the analysis program to consist of Kenneth Oppenheimer, Stewart Wilson, and himself.

Discussion instituted by President regarding type of programs club shall employ. Discussion on publicity, which up to this time has been handled by John Stick.

President stated floor open for suggestions on a Program Committee. Stew Wilson suggested competitions to try slides out on the local areas for national competitions, as a proving ground. General discussion regarding the difficulty of obtaining competent judges, one reason for not having regular competitions. President suggested a questionnaire be issued asking what type of programs the members would prefer. President suggested the board members present tape a greeting to Paul J. Wolfe, Chairman of the Stereo Division of PSA.

Kenneth Oppenheimer asked duties of Membership Committee, and general discussion followed. President suggested chairman have help and train them for the coming year. Decided that Publicity should operate in conjunction with Membership Committee Chairman Kenneth Oppenheimer. Discussion re publicity - should reach PSA Journal, various photography magazines, Stereogram, Roundup Editor, etc.

Mr. Stick made motion to effect that there be a family membership - husband and wife - \$7.50 per year, in addition to the single membership of \$5.00 per year. Second and passed.

The Analytical Committee will accept slides for analysis from members up to a pre-determined limit. These slides will be analysed by three competent persons selected by the Board of Directors. The member will receive a written analysis of his slide, as well as points for Interest, Stereo, Color, Technique and Composition.

The Technical Advisory Cormittee will answer any questions concerning Stereo Photography, as long as they are not elementary or as long as their answer is not readily available in current publications. Members will have to submit their problems in writing with a stamped return envelope and accompanied by the problem slide - if a special slide problem has to be answered.

These services will first be available only locally, to be extended later statewide and eventually nation-wide.

The purpose for the creation of these two new committees is to assist the serious Stereo Photographer to get the fullest enjoyment from his hobby and to achieve Stereo Slides of salon quality.

The work of the analytic cormittee will help in training of qualified Stereo Salon judges.



MINUTES

1956

Meeting of the Board of Directors was held on May 9th ∧at the home of President, Dr. Harold R. Lutes, all directors being present with the exception of Lee Sorensen.

Meeting was called to order and President asked Program Chairman, Bob Hartung, for report. He stated that the planned program by Colonel Bud Andersor for the next meeting would have to be postponed until a later date, as Colonel Anderson would be out of the city on that date. Board was asked for suggestions for a substitute program. Several alternatives were discussed, and it was finally decided that Bob Hartung would present a show of "SCENIC SLIDES OF THE SOUTHWEST". For the instructional portion of the program, it was decided to invite members to bring 3 slides each for criticism, with a panel of three anlaysts to discuss the slides.

President asked for discussion regarding the shooting session which was postponed in April.
